

The community connection grant is open to any Sturgeon County resident who has an idea for an activity or event aimed at building neighbourhood connections and promoting inclusivity among residents. This can be done in a variety of ways, such as: block parties, neighbourhood swap meets, outdoor movie nights, meet and greets in your local park, and community clean-ups. It could even be something like snow castle competitions or pumpkin carving.

Applicants planning an event for 30 – 100 people are eligible for up to a \$100. Applicants planning an event for over 100 people are eligible for up to \$200. County administrative support on permits, help with advertising, one on one planning meetings, support inviting special guests (council members, mayor, fire or police), and additional supplies (activity kit, lawn games, board games, canopies) are available to all applicants. Also, if your event involves a clean-up component, you are eligible to receive supplies such as bags, gloves, water bottles, garbage pickers, etc.

The project must:

- Be open to all residents
- Support or create community connections
- Take place in Sturgeon County

Note: Family reunions, birthday parties, and religious functions are not eligible.

Be creative! If you have an idea that isn't on our list, please contact the Community Program Coordinator at 780-939-8335 to discuss your idea prior to completing the application.

Applications will be considered throughout the calendar year based on available funding. All applications must be received at least two weeks in advance in order to be taken under consideration.
