

### Early bird deadline April 16, 2024

A late fee of \$100 is applied to orders received after that date.

No orders will be accepted after May 17, 2024.

The cost to apply dust suppression is shared between the County and applicant. Fees vary based on the type of suppressant used and the length of application.

## **PLEASE NOTE:**

- Applying dust suppression products can help reduce dust on gravel roads, but it does not eliminate it.
- •The first 100 metres of dust suppression is subsidized by the County. The 2024 subsidy is \$775 per resident. Additional length may be purchased in 10m increments, up to 100m, at full cost.
- Application forms are processed in the order they are received. Your neighbour's stakes may appear earlier than yours.
- **Do not move County stakes once placed.** Call 780-939-4321 to request changes.
- Sturgeon County may undertake work on any treated areas to maintain a safe driving surface.
