Waste Bylaw


Bylaw 1011/04 - Waste Management Services

- Sets a maximum of 8,000 kg of domestic waste accepted free of charge at Roseridge Landfill.
- Waste exceeding the limit is charged per 1,000 kg, with fees set by Council.
- Recycling & Yard Waste Drop-Off available at Roseridge Transfer Station & Waste Management Center.
- Council Notice of Motion: Exploring curbside collection options to enhance waste strategy.
